INVITATION FOR PRE – QUALIFICATION PRE – QUALIFICATION NO: LGA/016/2018-19/HQ/Preq-01

1. The government of the United Republic of Tanzania has set aside funds for the operation of the Temeke Municipal Council during the financial year 2018/2019. The Temeke Municipal Council has allocated funds from various sources, and intends to use part of the funds towards the cost of procurement of various Goods, Works and Services.
2. The objective of pre-qualification as stated in section 47 of the Public Procurement Act No. 7 of 2011 Regulations 2013 amended 2016 is to identify competent firms/companies which will be called upon from time to time to quote/tender for supply of goods/provision of works and services during the financial year 2018/2019.
3. Pre-qualification is open to all tenders for the activities specified in clause 4 below.
4. The Temeke Municipal Council now invites suitably qualified and competent bidders to submit sealed pre – qualification bids for:-

5. Pre – qualification will be conducted through the National Competitive Tendering procedures specified in the Public Procurement Act (Goods, Works, Consultant Services, Non Consultant Services and Disposal of Public Assets by Tender) Regulations 2013 amended 2016 – Government Notice No. 446.
6. Interested eligible Tenderers may inspect and obtain the Pre-qualification information and documents at the office of the Secretary of the Tender Board at Temeke Municipal Council from 9.00 am to 3.30 pm (Monday to Friday) upon payments of non – refundable fee of **Tshs. 50,000/=**

7. After review of Prequalification documents, a short-list will be prepared and only those short-listed applicants will be invited to tender or submit their quotations whenever needs arise.
8. All applications must be submitted in two copies enclosed in plain **sealed envelopes**. All bids must either be delivered by hand or be sent by registered mail so as to reach the Office of Secretary of Tender Board at Temeke Municipal Council Head Office before **11.00 AM on 17th April, 2018**. Bids sent by post must be registered.
9. The deadline for the submission of applications will be 11.00hrs local time on **17th April, 2018**. Applications will be opened in public shortly thereafter in the presence of applicants/representatives who wish to attend at Temeke Municipal Council Head quarter **Idd Nyundo Conference Hall**.

11. Late Tenders, Portions of Tenders, Electronic Tenders, shall not be received, not opened and not read out in public at the tender opening ceremony and shall not be accepted for evaluation irrespective of the circumstances.
